## THIRD ORDER OF BUSINESSDiscussion of the Fiscal Year 2026 Budget

The Board went over the proposed budget for fiscal year 2026 and discussed making the

following changes before the budget is presented for approval at the next board meeting:

- Increasing supervisor fees by \$2,000 to allow for extra workshops
- Increasing district counsel fees to \$65,000

- Increasing irrigation repairs and maintenance to \$50,000
- Reducing tree replacements to \$2,000
- Increasing tree pruning to \$17,000
- Increasing amenity landscape maintenance and improvements to \$50,000 to include pine straw for the fitness center
- Increasing gate repairs and maintenance to \$5,000
- Reducing miscellaneous field supplies to \$2,000
- Increasing the outside fitness professional services to \$60,000
- Reducing fitness equipment repairs and maintenance to \$5,000
- Reducing fitness equipment rental to \$30,000
- Reducing cleaning supplies to \$10,000
- Reducing the capital reserve contribution to \$100,000

Additional comments were that the mulch line item should be changed to pine straw. Ms. Henley noted that the automatic renewals for the landscape maintenance contract end this year, so the District will need to issue a request for proposals.
